# **Tournament Waiver Instructions**

Osceola Angler tournaments will begin in October. Each angler must pay fees prior to participation in tournaments. Along with tournament registration fees, a release of liability must be signed by the captain, angler, and the angler's parent/guardian. It is the responsibility of the angler to bring the completed forms with them when registering for a tournament. Forms will not be provided at the time of registration. You can print the forms located in the tournaments section of the Osceola Anglers website. This form must be provided for EVERY tournament.

For the safety of all participants, one - (2) two-person team of contestants will be in each boat, with one volunteer boat captain, three people to a boat NO EXCEPTIONS.

Pursuant to federal law guidelines under the Safe Sport Authorization Act of 2017, there MUST be three people to a boat at all times. No exceptions. No angler may register or plan to fish alone. In the case of a verifiable, unplanned emergency, where one partner is unable to attend and no time is left to find another partner, only then may a tournament official, at their sole discretion, allow an observer in the boat in place of a fishing partner. The observer may not fish.
